Committee Makeup

The Update Series Editorial Committee consists of a total of 12 members. Member appointments are based on expertise in areas of specialization and recommendation of the Update Series Editor with approval of the Education Chair.

Vision/Mission/Purpose

Mission Statement: The AUA Update Series is dedicated to presenting timely, concise and focused reviews on topic oriented issues in urology and related fields.

Statement of Purpose: Topics and authors are selected by the Update Editorial Committee which has a broad experience in urology. All manuscripts are peer reviewed by Update Series members with special expertise in urological subspecialties. The primary audience is intended to be the practicing urologist and urology resident in training.

Topics are selected by members based on the educational need assessments associated with AUA's Core Curriculum and the American Board of Urology's Life Long Learning modules, in addition to surveys solicited from the readership as well as timely subjects in the field of urology.

Committee Meetings

In November 2003, the AUA Board of Directors agreed that the Update Series Editorial Committee may have one resort style meeting to include spouses. A second meeting may take place at AUA Headquarters Facility (without spouses) or be held via teleconference. The timing of each meeting is to be determined by the Editor.

Time Commitment

Workload varies throughout the year, estimate below as follows:

Editor: 6 hours per week or 250 hours per year

Associate Editor: 3-5 hours per week or 200 hours per year

Compliance

Committee positions are open to AUA members in good standing. All new members are required to agree to abide by <u>AUA's Civility Policy</u> when they accept their appointment and agree to annually complete a COI Disclosure Form in accordance with <u>AUA's COI Disclosure Policy</u>. The AUA reserves the right to suspend or remove a member from participation in any AUA activity while the individual is under investigation for a violation of AUA's policies.

Criteria for Selecting New Members

- Expertise in a urologic specialty area, such as endourology, urologic oncology, pediatric urology, male infertility and andrology, female pelvic medicine and reconstructive surgery, etc.
- Excellent organizational and written communication skills are required to review and edit lessons within editorial timelines.
- Experience on the ABU Exam Committee is prioritized but not mandatory.
- So that the AUA is in compliance with ACCME Standards, Members of Office of Education committees are not permitted to have financial relationships with ineligible companies (formerly commercial interests) that the ACCME would deem to be that of an owner or employee. Owners are defined as individuals who have an ownership interest in a company, except for stockholders of publicly traded companies, or holders of shares through a pension or mutual fund. Employees are defined as individuals hired to work for another person or business (the employer) for compensation and who are subject to the employer's direction as to the details of how to perform the job.

Criteria for Selecting Next Editor

The Associate Editor serves a three-year term and succeeds the current Editor as the completion of his/her term. The Associate Editor must be a current or past editorial committee member and is selected by the current Editor with approval of the Education Chair. The Associate Editor should be a nationally recognized accomplished urologist, and must have exceptional organizational, communication and leadership skills. Previous experience on the ABU Examination Committee or similar question writing experience is highly recommended.

Recent Accomplishments 2024
