Disclosure Requirements

The AUA requires that prior to participating in programs all individuals make full disclosures of all financial and intellectual conflicting interests (COIs), i.e., private or institutional interests of individuals which may, under certain circumstances, compete or conflict with their duties owed to the AUA. These COIs include affiliations, ownership interests, investment interests, intellectual property interests, business or employment relationships, scientific studies or trials, presentations or publications, with (1) any entity researching and developing, producing, marketing, selling, re-selling or distributing healthcare products used by or on patients (2) healthcare publications or (3) other medical associations.


Disclosure Period

Any existing relationships within the past **24 months** should be disclosed prior to assuming a role with the AUA. Ongoing disclosure of new relationships is also required for the duration of that role.

Records must be updated after **April 1** to be considered current for the Association Year (June-May). Participation in certain AUA activities may require you to review and confirm disclosures more frequently than once a year.

COI Disclosure Program Main Page

Editing Disclosures: Confirmed disclosures are part of a member's permanent record and cannot be deleted. Members may edit the company type, specialty area, description or end date. If a disclosure is no longer current select edit to add an end date to conclude the relationship.




