Definitions

Domestic Members:

AUA members from the United States, American Samoa, Belize, Canada, Costa Rica, El Salvador, Guam, Guatemala, Honduras, Mexico, Nicaragua, Northern Marianas, Puerto Rico, Republic of Panama, U.S. Virgin Islands, and the island possessions of the United States in the Pacific Ocean and geographically belong to one of the eight AUA sections.

Domestic Urologist Membership:

Domestic members in one of the four membership categories: Active, Associate, Senior, and Honorable.

Domestic Practicing Urologist Members:

Domestic Urologist Members who identified themselves as practicing urologists in 2020.

Data and Methods

Study Population: 11,140 domestic practicing urologist members in 2020

Study Samples: 2,342 domestic practicing urologist members who completed the 2020 Census

Member Exclusion: Members with missing information on section membership status and age in 2020

Sample Weighting: To adjust for non-response bias, a weighted value was assigned to each sample based on gender, age and geographic location. Weighted samples are used to proper representation of their corresponding urologist members in the study population.

Data Analysis: After the post-stratification weighting adjustment, weighted Census samples were analyzed using IBM-SPSS Complex Samples 27.0.

<u>Primary Limitations</u>: No practicing urologist master files are available outside the United States to help verify each urologist's practicing status. Thus, the self-reported practicing status in 2020 was used for this purpose across the domestic regions. Results are also subject to common recall errors that are associated with survey participation.



Average Age of Practicing Urologist Members in Workforce (in ascending order)









Percentage of Fellowship-Trained Practicing Urologist Members (in ascending order)














Percentage of Practicing Urologist Members with a Primary Specialty Other Than General Urology (in ascending order)





(Total work hours (Blue); Clinical work hours (Grey)





Average Number of Patient Encounters per Week (in ascending order)







Average Number of Minutes Spent with Patients in a Typical Office Visit (in ascending order)







Average Number of Nights on Call per Week (in ascending order)







Average Number of Major Inpatient Operative Procedures Performed per Month (in ascending order)









Percentage of Practicing Urologist Members Collecting Patient-Reported Outcomes (PRO) Information (in ascending order)







Percentage of Practicing Urologist Members Using Online Surveys to Collect PRO Information (in ascending order)







Percentage of Practicing Urologist Members Participating in Telemedicine (in ascending order)






